- vii. Candidates seeking reservations under EWS are required to <u>submit income & assets certificate in the</u> <u>format applicable for Economically Weaker Sections</u>
- viii. Candidates employed in Government / Quasi-Government / PSU, should send their online application through proper channel or produce NOC at the time of assessment as the case may be. At the time of joining, the selected candidate must provide a clear relieving letter.
- ix. Candidates employed in Government / Quasi-Government / PSU, should have worked for at least one (1) year in the immediate lower scale.
