II. TERMS & CONDITIONS: -

- 3) Drawings forwarded are for the purpose of quotation. If order is awarded, supplies have to be made as per controlled copy of drawings which will be sent by division.
- 4) In case of firms is not in BEML vendor base and becomes L1 such firm will be assessed before placing Purchase Order. On assessment, if L1 firm is not recommended then L2 firm quote will be considered for further evaluation and so on.
- 5) Supplier has to indicate the development charges such as Pattern/ die/Tool/ Jigs & Fixtures cost separately if any in the notes of SRM portal.
- 6) Supplier has to specify clearly, whether the Pattern/ die/Tool/ Jigs & Fixtures is the property of BEML.
- 7) Payment Terms: 30 days after receipt and acceptance of material for Micro, Small Enterprises (MSE's) and 60 days after receipt and acceptance of material for others. *In case of Micro & Small Enterprises, supplier has to upload the Udyog Adhaar Certificate inthe attachments of SRM portal.

- 9) Taxes: Firm should mention applicable GST in their quotation legibly.
- 10) Firm has to submit the quotation for the tendered quantity.
- 11) The quantity mentioned in the enquiry is only for the developmental order and once the part is accepted by BEML, they will be considered for the regular supply as per the Purchase procedure.
