- iii) Delivery schedule: Within 30 days from PO date on F.O.R., BEML Mysore. Early delivery is acceptable.
- iv) Payment terms: As per Annexure-1
- v) Quotation validity: 60 days from tender closing date.
- vi) Please indicate applicable taxes and HSN code.
- vii) RFQ terms and Important terms & Conditions are to be referred while submitting the quotation.
- viii) Liquidated damages applicable for delayed supplies at 0.5% per week upto maximum of 5%.
- ix) Vendors to submit technical compliance as per the technical specifications enclosed with the enquiry. Quotations without technical compliance will not be considered for bid evaluation and bids will be rejected.
- x) Technical bids should not contain price details. In such case, bids will be rejected. Hence, vendors are requested to submit technical bid and price bid separately
- xi) Compliance to Commercial terms & conditions to be submitted.
- xii) Class-3 Digital signature with encryption is mandatory for online Bid submission in the BEML SRM portal.
- xiii) New suppliers can contact SRM team for temporary vendor codes, password and other necessary assistance for online Bid submission in the BEML SRM portal.
- xiv) Vendors are requested to submit Earnest Money Deposit (EMD) of Rs.30,000 through Demand Draft payable to BEML, Mysore. EMD is exempted for MSME vendors against NSIC certificate with EMD exemption. EMD will be returned to unsuccessful vendors after finalizing the L1 vendor.
- xv) Security deposit of 10% of PO value to be submitted by L1 vendor after receipt of PO.
- xvi) Warranty : 12 months from the date of acceptance of lead sheet for material defects.
