General Physical verification for MANGO PICKLE.

- Pickle should be fully seasoned, good taste & smell.
- Pickle should be prepared from good quality of refined Oil.
- Pickles should be prepared using good quality of Mango.
- Pickles should not contain any type of preservatives.
- Brands to be confirm to AGMARK / FASSAI / relevant IS standards.

Based on the above parameters the samples submitted by the firm will be selected by the sample selection committee which is final and binding on the firm.

Note:

**Technically qualified Bidders representatives shall be invited to witness the testing / cooking done by BEML Ltd., for evaluation / selection of samples.**

Do not send any commercial related documents in the technical (Sample) bid, commercial details in technical bid will lead to rejection of bids.

Only the Technical bids will be opened first and will be sent for technical evaluation. Commercial bids of technically qualified bidders only will be opened. Further negotiations will be made only with technically qualified and lowest bidder as determined by the committee.

- Clearly mention all the applicable taxes in SRM.
- Commercial bid submitted in the system (SRM) without submission of samples will not be considered.

Please upload the duly signed scanned copy of the document mentioning following terms on your company letterhead in the collaboration folder in the system.

- 1) If we are successful bidder minimum lead time required for supply of item after placing Purchase Order will be\_\_\_\_\_ days.
- 2) We accept the price contract for a period of one year with effect, tentatively from July 2020 TO June 2021.
- 3) We accept payment terms i.e. 60 days credit after receipt and acceptance of the item.
- 4) Delivery: FOR Destination basis at Bangalore Complex, Bangalore.
- 5) The price is firm for a period of one year. Price quoted is on FOR Destination.
- 6) We accept 10% of PO value as performance guarantee by deduction of 10% of PO value in first supplied bill or submitting bank guarantee of 10% of PO value through Indian public sector bank to be submitted within week time after receipt of PO.
