SUBMISSION OF Technical BID THROUGH SRM PLATFORM

Technical Bid (Sample of Cleaned Sona Masori Raw Rice)

You are requested to send the **25 Kg of samples for evaluation** in sealed bag. Paste a slip with name of firm. Sample should be submitted along with covering letter mentioning the tender enquiry reference number on envelope.

NOTE: Firms are requested to upload the sample test report stating the rice sample supplied is SONA MASORI RAW RICE from NABL accredited Lab for the sample

SUBMISSION OF COMMERCIAL BID THROUGH SRM PLATFORM

Commercial Bid to be submitted through E-mode as per the format by clicking on **Item Data** tab. Bidder has to quote basic price, applicable GST in the item data column. Applicable GST can be selected from the dropdown box. In case any applicable GST are not available in the dropdown box, the same may be clearly mentioned along with % in the #bidders remarks#.

If you are successful bidder the items supplied by you shall be inspected and accepted by the Selection Committee.

Selection committee shall inspect and select the item during bulk supply with respect to the testing parameters specified below:

Sona Masuri Raw Rice, fine quality, seasoned, free from broken rice, paddy, husk, stones and other impurities (Cleaned Sona Masuri Raw Rice)

Physical verification for:

1. Raw Rice
2. Non-Availability of Broken Rice
3. Non-Availability of Paddy
4. Non-Availability of husk / stones / impurities / worms /foreign materials
5. Non-Availability of Mixed Rice
6. Taste of Raw Rice
7. Uniform grain size
8. Colour

After cooking verification for:

1. Yield (Minimum yield 2.5 times by weight)
2. Taste
3. Pasty/Non-Pasty
4. Stick/Non-Stick
5. Appearance

Based on the above parameters the bulk quantity supplied by the firm will be selected and accepted. If required the firm has to self certify for any of the above parameters mentioned.

NOTE: Firms are requested to upload the sample test report stating the rice sample supplied is SONA MASORI RAW RICE from NABL accredited Lab/government approved Lab for the sample. Firm is also requested to provide Self certification that the rice supplied is SONA MASORI RAW RICE.

In case the committee rejects the bulk supply the firm has to take back the bulk supply and send fresh supplies immediately within 1 day at his own cost nothing extra shall be paid.

Terms & Conditions:

1. Quantity indicated is tentative and it can vary on either side depending upon the requirement. No claim whatsoever may be made at a later date regarding the quantity variation. **This is unit rate Contract only.** Items to be supplied against quantity specified in the Purchase Order placed on the successful bidder from time to time based on the actual requirement.
2. FAX / e-mail quotations are not acceptable and quotations will be rejected. Incomplete offers are also liable for rejection.
3. The quoted price / rate should be firm for **six months**. The quoted price/rate should be valid for acceptance of tender for a period of 90 days from the closing date of this tender.
4. BEML Limited reserves the right to accept or reject any offer in part or full which shall be binding on the supplier. BEML reserves the right to short close the contract/Purchase order.
5. The order will be placed on L1 firms. In case two or more firms are L1 for a particular item the order will be placed on both or more firms for the quantity which will be divided equally among the L1 firms.

6. Canvassing by tenderers in any form including unsolicited letters on tenders submitted or post tender corrections shall render their tenders liable for rejection.
7. **Payment Terms:** 100% Payment will be made on 60th day from the date of receipt of the ITEMS at BEML, Bangalore Complex for accepted quantity against original Invoice.

For any deviation in payment term, appropriate interest loading (12.00% annual simple interest) will be done on landed cost for comparative statement for commercial bids.

8. **Delivery Schedule:** FOR BEML Ltd., Bangalore Complex within 2-3 days from the date of indent for supply of materials.
9. Liquidated damages (LD) shall be applicable @ 0.50% per week and part thereof, subject to a maximum of 5% of the value of the delayed portion of the item.
