Our 20Cu.M. Electrical Rope Shovels are equipped with lubrication hoses supplied by M/s LINCOLN INDIA (SKF). In connection with this we are planning to invite Open tender in **single bid system** from Lincoln India or its authorised dealer / distributor who have previously supplied lubrication hoses to HEMM or other heavy duty applications. Copy of credentials confirming such supplied made in the past to be enclosed along with technical bid.

### **Description of Work:**

**Supply of lubrication hoses for use on 20 Cum Rope shovel.**

### **Scope of work & Notes:**

1. The tender is for supply of various types of lubrication hoses to use on 20CuM Rope Shovels from the date of placement of firm Purchase order.
2. The quotation should clearly indicate the price of individual hose. The quantities indicated in the tender is tentative with a variation of (+/-) 10% during placing the PO.
3. Lubrication hoses to be supplied at our Regional Stores, Jhingurdah Colliery.
4. The quoted rates should be inclusive of packing & forwarding charges including logistics & transit insurance.
5. The supplied items not meeting the specifications (size, grade or quality) will be summarily rejected. Firm will have to replace the same on no additional cost to BEML.
6. The tender document will indicate part numbers of both BEML & Lincoln India for ease of submission of quote.
7. Firm has to quote per item per quantity.
8. 100% payment to the extent of stores supplied will be made within 21 days after receipt & inspection of materials at our stores.

**Eligibility:**

The tenderers should have previously supplied lubrication hoses for HEMM or other heavy duty applications from Lincoln India or its authorised dealer / distributor.

7. In the event of furnishing false information / incomplete information, the offer(s) shall be rejected.
8. The lowest bidder will be considered individually for each item.
9. BEML Ltd. Reserves the right to reject any bid, which is technically unacceptable and unworkable. Further BEML Ltd. Also reserves the right to reject any or all bids without assigning any reasons thereof.

## **Tender Document**

### **(Techno-commercial – Response to be submitted)**

#### **1. FORCE MAJEURE**

The firm shall not be responsible for any delay in execution of this contract if the delay is caused as a result of Force Majeure.

“Force Majeure” means an event beyond the control of the Contractor, such as Floods, wars or revolutions, epidemics, strikes (caused by other than contractors own employees/ workmen), terrorist attack etc.

#### **2. ARBITRATION CLAUSE**

If BEML and the contractor are not able to resolve any contract dispute amicably within a reasonable period of time, such disputes shall be referred to a sole Arbitrator to be appointed by BEML and the proceedings before the Arbitrator shall be governed by the provisions of Arbitrations and conciliation Act 1996, in which event the Arbitration proceedings shall be held at Bangalore and the Arbitrator shall be required to give a reasoned award. Courts in Bangalore alone shall have jurisdiction in the matter.

#### **3. APPLICABLE LAW**

The contract shall be interpreted in accordance with the laws prevailing in India.

#### **4. JURISDICTION OF COURTS**

The courts in Bangalore only will have jurisdiction.
