- 1. Timings:** Vehicles should be provided for a period of one year (300 working days) 12Hrs / 50Km per day operation including Fuel and Driver as required by BEML. The requirement may get revised depending upon the BEML requirement. **Vehicle should report to Transport/Maintenance Dept, BEML (Palakkad Complex) timely as per requirement.**
- 2. Distance:** Rate should be quoted per day minimum of 50Km and/or minimum of 12Hrs per day. Rate for extra kilometers (beyond 50 km) and extra Hrs (beyond 12 Hrs) should be quoted separately.
3. Estimation of rate contract arrived for a period of One year on an average requirement for car days basis as per enclosed **Annexure-I**. However, bills will be submitted once in a month basis on actual usage.
4. The rates quoted per day should be all inclusive such as Fuel, Maintenance, Drivers salary, Batta for Day/Night, Insurance, Emission test, Fitness certificate, Road Tax, etc.
5. The contractor should cover all the statutory legislations including motor vehicle Act and regular enumeration to drivers. BEML will in no way responsible for the non-compliance of the same by the contractor.
- 6. PAYMENT TERMS:** Payment will be made monthly basis on actual usage. The contractor shall submit the bills certified by the Maintenance Dept. on the first week of the succeeding month and the BEML shall pay the bill within ten days of receipt of the bill along with statutory tax payment receipts. The monthly bill should accompany with the daily trip sheet duly coordinated & endorsed by Security Department.
- 7. SECURITY DEPOSIT:**

The Contractor has to execute a Bank Guarantee within 30 days of issue of acceptance letter to the Dy. General Manager (Purchase), BEML Ltd, Palakkad Complex for a value equal to 10% of Work Order value (excluding taxes) which should be valid up to 6 months after completion of contract period. Such Security deposit shall not entail any interest payment on refund. In case of extending the contract the contractor is required to renew the Bank Guarantee before one month of its expiry with same validity failing which same will be realized by the BEML Management. The Bank Guarantee should provide for indemnifying BEML from all losses arising out of this contract directly or indirectly during the validity of this contract apart from adjusting any due from the contractor at any time. In case of non-submission of Bank Guarantee, equivalent amount will be withheld from contractor bills which will be refunded only after completion of contract.

8. Refund of Security deposit: On completion of the contract, based on the recommendations of the Maintenance department, the security deposit will be released to the contractor.
9. Decision of BEML Management is final and binding in awarding of the contract.
10. In emergent cases, additional vehicles required by BEML should be provided at the same rates and accepted terms and conditions
11. The driver should report wearing clean white uniforms (Pant/Shirt) and shoes with valid driving license and all vehicle related statutory documents failing which they will not be allowed to enter factory premises.
12. The present requirement is as per the details mentioned in specifications. However, the number of vehicles to be provided may be increased or decreased at the time of finalizing the contract or during the tenure of the contract.
13. The contractor should always ensure that the vehicles should ply on our authorized routes as specified by BEML in our 'LOG BOOK' kept for vehicle at Security Main gate. Vehicles should be provided on 12 Hrs /50 Km per day operation including Fuel and Driver. The Hours/Kilometer will be arrived as per gate entry (IN/OUT) made in 'LOG BOOK' kept for vehicle at Security Main gate for each day. The total Kilometer and Hours as per the log book will be taken for payment purpose. Payment for extra Kilometer (**beyond 50 km per day**) and payment for extra hours (**beyond 12 Hours per day**) will be made as per actuals in Gate entry. However, any special case / conditions as per the instruction of BEML, the Kilometer will be arrived on point to point basis, i.e. from First pick-up point to last drop point and the same may be certified by the Transport/Maintenance Department.
14. All trips should be properly mentioned in 'LOG BOOK' kept for vehicle at Security Main gate. The total distance covered in a month and total hours served in a month will be taken from the Log book entries (kept in Security Gate) of each day for the particular month. Payment for **extra distance** is "**Total Km run in a month – (Number of working days X 50 km)**" and for **extra hours** is "**Total Hrs run in a month – (Number**

of working days X 12 Hrs)” will be made based on the transport department certification.

15. The Driver should maintain their Log Book/Log sheet recording the distance covered and the places visited, the total distance covered (opening & closing meter readings) daily basis and certified by the Transport/Maintenance Department and copy of this should be furnished along with the monthly bill in support of the bill.
16. The contractor should provide the vehicles with fuel (Diesel/Petrol) and experienced well behaved Drivers with white uniforms/shoes and familiar with Palakkad/Coimbatore areas as per BEML requirement.
17. The vehicle deputed for BEML should be not more than 5 years old. In case of vehicle not meeting the year / model standards, the vehicle will not be permitted for duty. The vehicles should be in good operating condition, good in appearance and should give trouble free performance at all the times. The vehicles should be kept in clean/tidy and hygienic condition.
18. The rate quoted should be Contractor throughout the period of Contract (One year) and no increase in rate shall be entertained under any circumstances except for reason mentioned in Point no 19. The rentals as per the contract shall be Contractor during the validity period.
19. Price Variation Clause: Any increase or decrease in Fuel cost less than 5% on the base price during the currency of the contract will be ignored. If the increase or decrease in Fuel cost is beyond 5%, rates shall be proportionately charged extra or reduced as the case may be. For price variation clause rate of High speed Diesel rate only considered. For the purpose of Price Variation calculation, Mileage per Diesel vehicle is as follows:

Etios/ Dzire / Xcent/ Amaze (or equivalent): 13 Km

The applicable formula for calculating Price Variation is given below:

20. The price of High Speed Diesel for Palakkad as per IOCL's website <https://www.iocl.com/products/High Speed Diesel.aspx> on the 1st day of respective month will be considered for price variation clause.
21. The base price of High Speed Diesel for this tender/contract is Rs. 92.77 per litre on 30.12.2021.
22. Vehicle should be registered with appropriate RTO authorities for movement in any part of India and should have only Yellow board with black letters number plates as per RTO rules and regulations with valid RC, permit, Insurance, Emission cert etc.

23. In case of any accident/breakdown, the Contractor should attend the formalities with Traffic Police/RTO Authorities as well as Court proceedings including claims under Motor Vehicles Act, if any, as the case may be. In such events alternative transport arrangements should be made available by the Contractor within a short span of time. BEML will neither bear any cost arising out of such eventualities nor liable / responsible for any lapse on the part of the Contractor.
24. A well-equipped First-Aid kit should always be made available in the vehicle to meet any emergency as per RTO rules.
25. Delay in reporting due to traffic congestion/riots, disturbances on route, beyond control should be brought to the notice of the Management for taking appropriate decision. Contractor is also responsible to provide vehicle as and when required by BEML even during the Holidays/Sundays.
26. The Contractor should provide the vehicle as per BEML instruction, if the vehicle is not provided as per requirement BEML reserves the right to engage private vehicle and deduct the equivalent amount incurred for the trip plus penalty of Rs. 500/- per occasion from the Contractor's monthly bill.
27. The Drivers engaged should be well behaved, polite with pleasing manners, cooperative, disciplined and knowledgeable. They should not resort to drinking, smoking, misbehave while on duty and should not engage in needless conversation with the VVIP's while driving.
28. The Drivers should keep up the punctuality while reporting for duty, also at pick-up /dropping points of the concerned executives. A minimum waiting time of 10 minutes should be allowed while picking up the VVIP's from their residences/location.
29. In case of any breakdown / accidents en route, the Contractor's Driver should immediately inform the transport authorities of the BEML as well as the Contractor to make immediate alternative arrangements, or to take necessary action depending on the situation, failing which BEML is liable to deduct the expenditure incurred by the official from the bill amount.
30. The Contractor will be held solely responsible for proper conduct, behavior and safety of the drivers. BEML will be no way responsible for the lapses on the part of the Drivers / Contractor whatsoever may be.
31. The drivers should strictly follow traffic rules and regulations. Contractor only shall bear any Penalty imposed due to over speed, traffic violations etc.
32. BEML will not be responsible for any loss, damages, loss of life of Contractor's Drivers in case of any accident. In case of any loss caused to BEML property / passenger while offering services, the same will be made good by deducting proportionate amount out of the Contractor's monthly bill/EMD/Security deposit.

33. Contractor should ensure that un-authorised passengers should not be picked up while on BEML duty.
34. The Contractor should ensure payment of proper Comprehensive Insurance coverage Emission Test Certificate, Fitness certificate, Road Tax, Inter-state Permit for the vehicle engaged by BEML along with RC Book and valid driving license should kept in vehicles. The Vehicle should be registered under the Contractor`s name or in the proprietors name only.
35. The rentals are exclusive of GST (if any) and the same will be on actual basis after ascertaining the applicability from time to time and also on production of relevant/specific proof of such payment made by the Contractor. TDS will be applicable.
36. Notwithstanding anything contained herein, the contract may be terminated by BEML at any time by giving 3 months` notice and/or without notice for breach on the part of the Contractor any of the terms and conditions of the contract. It is not obligatory on the part of the BEML to assign any cause or reasons for such termination. The contractor shall not be entitled to claim any compensation or damages for such termination.
37. Canteen facilities will not be available for drivers as such. Drivers should make their own arrangements for breakfast / lunch etc. They should be available for service even during lunch hours. If required, Canteen facilities will be provided on actual chargeable basis and amount will be deducted from Contractor`s bill.
38. Contractor has to provide a board with "BEML" logo has to be kept in front of the vehicle on BEML service.
39. The contractor should cover all other statutory legislations including Motor Vehicles Act and BEML will in no way responsible for the non-compliance of the same by the contractor.
40. Contractor will sole responsible for safety of their driver, passengers, vehicle and statutory obligations applicable and completely indemnify BEML Limited in case of any claim arise in due course.
41. The Contractor should submit all trip sheets for all duty, endorsed/duly signed by the user department on day to day basis.
42. The vehicle should be provided on the dates specified by the user.
43. Income Tax will be recovered at source as per IT Act.
44. Successful tenderer is required to execute contract agreement on Rs. 200/- stamp paper incorporating standard conditions in a prescribed format. The format will be given by BEML.

1. The Supplier is required to comply with all the applicable provisions of the GST Laws/Rules/Notifications/Circulars and to furnish required documents/details within the prescribed time limit to enable BEML to claim the benefits of GST Input Tax Credit or any other benefit.
2. The Supplier is required to furnish proper Invoice/Supplementary Invoice/Debit Note/Credit Note in the form and manner prescribed under GST Laws/Rules/Notifications/Circulars containing all the particulars mentioned therein and within the prescribed time limit as per prevailing GST Laws/Rules/Notifications/Circulars. In case of non-compliance by the Supplier, BEML shall not make any payment towards GST against such invoice until it is complied with within the timeline prescribed under GST Laws/Rules/Notifications/Circulars, and also subject to BEML being in a position to avail GST Input Tax Credit as per applicable GST Laws/Rules/Notifications/Circulars.
3. In case of discrepancy in the data uploaded by the Supplier in the GSTN portal or in case of any shortages or rejection in the supply, BEML will notify the Supplier of the same. Supplier has to rectify the data discrepancy in the GSTN portal or issue Credit note (details to be uploaded in GSTN portal) for the shortages or rejections in the supplies, within the prescribed time limit to enable BEML to avail GST Input Tax Credit.
4. In case, the availment of GST Input Tax Credit by BEML is delayed for any reason other than those attributable to BEML, interest at applicable rate as prescribed under GST Laws/Rules/Notifications/Circulars for such delays shall be recovered from the Supplier.
5. In case Supplier delays declaring such invoice in his GST Return and GST Input Tax Credit availed by BEML is denied or reversed subsequently as per GST Laws/Rules/Notifications/Circulars, GST amount paid by BEML towards such reversal as per GST Laws/Rules/Notifications/Circulars shall be recoverable from Supplier along with applicable interest.
6. If BEML has not paid/short paid to the Supplier for any invoices within the time limit prescribed under GST Laws/Rules/Notifications/Circulars due to non-compliance of GST Laws/Rules/Notifications/Circulars by Supplier or any other reason attributable to Supplier and leads to any GST Input Tax Credit reversal by BEML, any losses/expenses/cost/penalty, etc incurred by BEML shall be recoverable from the Supplier.
7. Wherever applicable, BEML will have the right to deduct "Tax Deducted at Source" at the rate prescribed under the GST Laws/Rules/Notifications/Circulars and to remit the same to the Government.
8. In case of supplies made under Reverse Charge Mechanism, the Supplier needs to comply with the provisions under the GST Laws/Rules/Notifications/Circulars in terms of supply of Goods/Services and raising of invoice, so as to enable BEML to remit applicable GST to Govt., within the prescribed time limit and avail GST Input Tax Credit on the same. If the Supplier fails to comply with the above and as a result if BEML incurs any losses/expenses/cost/penalty, BEML shall be entitled to recover the same from the Supplier. Further the Supplier has to mention that "the liability of payment of GST amounting to Rs is on the Recipient of Service" in the invoice raised on BEML.

9. The Supplier is required to comply with the E-Way Bill Provisions under GST Laws/Rules/Notifications/Circulars. If the Supplier fails to comply with the said provisions and as a result if BEML incurs any losses/expenses/cost/penalty, BEML shall be entitled to recover the same from the Supplier.
10. In case of materials/goods issued to Supplier for Job Work, the Job Work Supplier is required to return the goods within the time limit prescribed in the Purchase Order. If the Job Work Supplier fails to return the goods as above, BEML will be entitled to raise a GST Supply Invoice on the Job Worker Supplier with applicable interest as per the provisions of GST Laws/Rules/Notifications/Circulars. In such cases, BEML will be entitled to recover all such GST/interest on GST /losses/expenses/cost/penalty, etc. incurred by BEML along with interest from the Job Work Supplier. Further in such cases where the GST invoice has been raised by BEML, on return of such goods after the prescribed time limit, the Job Work Supplier needs to return the same under GST invoice.
11. GST portion of the invoice shall be released only upon the Supplier declaring such invoice in his GST Return and payment of GST thereof to appropriate government and satisfying all the conditions mentioned above. However, in case the Supplier wishes to obtain the payment of GST portion also along with the payment of the base value of the invoice, Supplier has the option to submit Bank Guarantee of an amount equivalent to the GST portion of the invoice plus 3 months' interest at prevailing rate of interest under GST Laws/Rules/Notifications/Circulars as applicable in case of reversal of GST Input Tax Credit. Such Bank Guarantee shall be valid till 30th September of the next financial year or filing of GST Annual Return by Supplier/Vendor (for which such invoice pertains to), whichever is earlier. BEML will release Bank Guarantee only when the Supplier declaring such invoice in his GST Return and remittance of GST thereon to the Govt. In case the Supplier fails to fulfil the required conditions resulting in BEML not been able to avail GST Input Tax Credit Bank Guarantee shall be encashed and such GST amount along with interest and any other cost/loss incurred by BEML shall be recoverable from Supplier.
12. The Supplier have the option to give one Bank Guarantee of appropriate value after considering his estimated value of GST involved in invoices raised on BEML instead of Bank Guarantee for each Contract/Invoice. In case of payment through LC, suitable provisions/clause will be inserted while opening LC to ensure compliances of above conditions. However, if at any point of time value of such Bank Guarantee falls short of GST plus interest thereof, Supplier will have to either furnish Bank Guarantee for Differential value or such shortfall value of Bank Guarantee vis-à-vis GST plus interest thereof shall be withheld till Suppliers fulfills its obligations specified under above clauses.
13. BEML will be entitled to recover all losses/expenses/cost/penalty, etc. incurred by BEML along with applicable interest from the Supplier due to reasons other than those attributable to BEML.
14. If the Supplier is a Composition/Unregistered Dealer, the Supplier needs to comply with the provisions under the GST Laws/Rules/Notifications/Circulars in terms of supply of Goods/Service and raising of invoice. In case, the Supplier fails to comply with the above and as a result if BEML incurs any losses/expenses/cost/penalty, BEML shall be entitled to recover the same from the Supplier along with applicable interest.
