**Scope of work for fitment of new undercarriage set in BD155 Dozer:**

- 1) Removal of all broken bolts from left and right track frame assembly, sprocket.
- 2) Surface finishing for mounting of rollers, idlers, sprocket teeth etc.
- 3) If any crack found during finishing the surface, same has to be repaired by welding and grinding.
- 4) Fitment of rollers, idlers and sprocket teeth. Tightening all the fasteners as per recommended torque as given in BEML Shop Manual.
- 5) Checking alignment and rotation of all rollers, idlers and sprocket teeth.
- 6) Fitment of track shoe assembly on both LH and RH side of Dozer.
- 7) Testing of Dozer for proper movement of all mounted undercarriage items.
- 8) If any abnormality observed during movement of under carriage items, immediately rectification for proper movement.

**Place of Work:** CSPGCL, DSPM Korba.

**Terms and Conditions:**

- 1) **Tools and Tackles:** All tools and tackles, consumables, manpower etc are to be arranged by contractor.

- 4) **Transportation:** Transportation of work men, material & tools-tackles from and to work spot has to be arranged by contractor.
- 5) **Vehicle entry:** Vehicle entry passes for the above work to be arranged by contractor.
- 6) **Period of Work:** The work completion period shall be within 10 days from the date of handing over of job.
- 7) **Penalty:** In the event of delay, Penalty @0.5% per week and maximum of 10% value of work order shall be imposed.
- 8) **Validity of offer:** The offered price should be valid for 3 months from the date of tender closing.
- 9) **Insurance:** All the workers/ personnel engaged for the work should be insured at your cost as per contract labour (Regulation & Abolition Act 1970) and copy of the policy is to be submitted to BEML/ Engineer in charge before starting of the work.
- 10) **Goods and Service Tax:** Please submit your GST No. TDS will be deducted as per govt. rule.
- 11) **Miscellaneous:** For the purpose of entry into premises of CSPGCL, DSPM Korba, token will be issued by CSPGCL DSPM Korba for your personnel. Personnel name and other details shall have to be produced on demand at any time.
