**2. The tender consists of two parts as indicated below:**

### **3. MANDATORY CLAUSES:**

The following Mandatory Clauses are to be complied without any deviation. In case of noncompliance to any of these clauses, the offer will be summarily rejected:

#### **a) REVERSE AUCTION:**

BEML reserves the right to conduct reverse auction, if required. However, the vendor has to mandatorily confirm to participate in reverse auction.

Reverse Auction procedure is as below:

- i. Firms to quote in two bid system i.e. technical and commercial bids.
- ii. BEML reserves the right to conduct reverse auction, if required.
- iii. **If reverse auction is conducted, then the start bid price for reverse auction shall be lesser than or equal to the quote in commercial bid.**
- iv. On completion of reverse auction, the commercial bid of technically acceptable vendors would be opened to verify the start bid price in reverse auction is equal or less than the commercial bid.
- v. **In case it is noticed that the start bid price is more than the commercial bid then the vendor will not be considered for further commercial evaluation.**

In case the technically accepted vendor is not participating in reverse auction, then the commercial bid of the firm would not be opened.
