BEML has sizable market share in domestic market with more than 10000 units of Mining & Construction equipment 18,500 Railway rolling stock, 1300 Metro Coaches and more than 11,350 Defence vehicles. ## 3.0 Pre-Qualifying Criteria:

- ❖ Applicant shall be a Dealer/Representative for a period of minimum 03 Years in sales and servicing of Earthmoving or Construction Machinery or Industrial diesel engine or Automobile Industry.
- ❖ The average annual turnover (including stock & sale) of the applicant company/applicant firm in three completed financial years (i.e. 2022-23, 23-24 and 24-25) shall not be less than Rs. 4.00 Crores from the above dealership business. Audited documents for 2022-23, 23-24 & 24-25 is required.
- ❖ The applicant, net worth as on financial year ending 31.03.2025 shall not be less than Rs. 1.00 Crore.
- ❖ The applicant should not have been debarred / black listed by Govt Departments / Undertakings of Government, banks and financial institutions in

India in the last 3 years. Applicant should furnish a declaration on its Letter Head conveying confirmation to this Clause.

- ❖ Applicants who are dealers of similar competitor models are not eligible.
- ❖ Applicants who are ex-dealer of BEML and now have issues to be settled under Legal/Arbitration are not eligible.

**Note:**

Supporting documents for the above must be submitted along with the application.

- I. Documents duly certified by CA/ Audited accounts for Annual turnover
- II. Documents duly certified by CA/ Audited Accounts for Net worth
- III. Dealership/Representative certificate towards proof to establish minimum 3-year experience.
- IV. Applicants not able to submit above documents to establish pre-qualifying criteria, their application shall not be considered for further process.

**4.0 Major operating points of the Dealership Agreement:**

- ❖ Dealer will look after Equipment sales in both Govt sector (Including PSU's, State PSUs, semi Govt organization, Municipal corporation) and Private sector pertaining to their territory except in those equipment tenders where OEM participation is mandatory. **However, defence organisation like DGBR, E-in-C and others are not included.**
- ❖ Parts and Service Support will be provided by Dealer to all customers i.e., both Govt. and Private **excluding defence organisation like DGBR, E-in-C.**
- ❖ Dealers are allowed to take AMC/FMC directly or through BEML as the situation demands, however Dealer has to use the BEML spare parts as per mutually agreed terms and conditions

Lower end Dozers, Front end Loaders, Back hoe Loaders, Excavators and Graders will be under Dealership agreement. The Models covered are as under:

- i. Bulldozers : BD85, BD80, BD65-1, BD50, and its variants.
- ii. Hyd. Excavators : BE300LC, BE220G, BE75 and its variants
- iii. Wheel Loaders : BL200-1, BL30-1 and its variants
- iv. Back Hoe Loaders : BL9H and its variant
- v. Motor Grader : BG605I, BG405A and its variants

- ❖ Initial Dealership agreement shall be valid for 2 years and can be extended for a further period at the discretion of BEML based on the satisfactory performance of the Dealer.

**Obligations of BEML Limited:**

- ❖ BEML will supply the equipment and spares parts against firm order of the Dealer or end customer.

- ❖ Any enquiry for equipment as well as spares parts of construction equipment received from both Government & Private customer directly by BEML within the territory allotted to Dealers, shall be forwarded to the Dealer. Equipment tenders where OEM participation is mandatory, BEML will submit the offer and conclude the contract. However, After Sales Service will be provided by the Dealer and the Dealer will be eligible for claiming Service commission.
- ❖ BEML shall provide **Technical/Sales support** and assist the Dealer in promoting BEML products and services.
- ❖ BEML will provide free training on BEML products at Manufacturing division/Marketing offices to Dealer staff. Lodging and Boarding to BEML account, traveling expenses by the respective Dealer.
- ❖ BEML will provide the Equipment Brochures and working videos for advertisement at free of cost.
- ❖ Sales/Service commission shall be applicable as per the dealership agreement.
- ❖ Annual Target for Dealers shall be set by BEML.
- ❖ Against closure of Dealership agreement, Security deposit amount will be refunded to Dealer after final settlement of Dealer account.

#### **Scope of Dealer:**

- ❖ Before signing Dealership Contract Agreement, Dealer will submit security deposit of Rs 20.00 lakhs in the form of DD/RTGS or Irrevocable BG of the same amount from any scheduled Bank.
- ❖ No interest shall be paid on Security Deposit.
- ❖ Dealer is responsible for Sale of Equipment, Spares & Service including submission of offer, follow up to conclude the contract and arrangement of finance.
- ❖ Dealer should display Brochure, Hoarding for advertisement in their office premises. For this Hoarding and Advertising purpose BEML will provide necessary photographs and other advertisement material and the expenditure to be borne by the Dealer.
- ❖ To continuously liaise with Customers and generate business for BEML Construction Equipment.
- ❖ To maintain sufficient stock of fast-moving spares such as Filters, O Rings, tooth points, Hoses, etc. for the maintenance & smooth operation of equipment.
- ❖ To keep minimum 1 service person for every 7 BEML equipment in their territory. However, the man power available with Dealer should be sufficient to render After Sales Service to customer.
- ❖ Sales promotion activities for local exhibitions will be on cost sharing basis, based on prior permission and joint decision.

## 5.0 Evaluation Criteria:

- ❖ BEML will evaluate the documents/ responses received from the applicants as per Annexure – A & B with supporting documents.
- ❖ Dealer Selection Committee shall evaluate the application as per the terms and condition and shortlist applicant/s for further evaluation.
- ❖ Selection will be based on evaluation by the committee and final interview to be conducted at Bangalore. Ratio will be 70:30 respectively.

## 6.0 General Instructions / Terms and Conditions:

- ❖ No payment will be made to the applicant for any expenses incurred by him/her for applying Dealership and also during the selection process.
- ❖ All information should be typed in English only.
