## SECTION-4

### Details of Expression of Interest (Eol)

#### 4.1 Introduction:

BEML proposes to establish an on-premise Industrial Edge AI capability to enable secure, local processing of enterprise and operational data without dependence on public cloud infrastructure. Towards this, BEML intends to procure, install and commission Industrial Edge AI Devices.

BEML accordingly invites Expressions of Interest from Original Equipment Manufacturers (OEMs) and their authorised partners who are capable of supplying, installing and commissioning the said solution.

For the purpose of this Eol, a “Industrial Edge AI Device” shall mean a compact, on-premise computing appliance combining AI processing hardware with pre-loaded AI models, applications, and enterprise-grade security features, deployed entirely within BEML’s Network. It shall be used to develop, test and deploy AI applications for internal company use, without use of public cloud infrastructure.

#### 4.2 Scope of Work:

- (a) Prospective Firm(s) should be ready and willing to fulfil following indicative scope of work:
  - (i) Supply, installation, integration and commissioning of an Industrial Edge AI Device as a single integrated hardware and software stack conforming in all respects to the technical specification at ANNEXURE – 5 of this Eol.
  - (ii) Demonstrate, at the time of installation, the AI models loaded on the system together with their provenance, and shall hand over documentation identifying the name, publisher and version of every model supplied.
  - (iii) Provide on-site training of BEML personnel after commissioning, covering administration, model management and use of the bundled AI applications.
  - (iv) OEM warranty for at least 3 years from the date of successful commissioning, covering both the hardware and the bundled software stack.
  - (v) Provide Annual Maintenance Contract (AMC) support for Industrial Edge AI devices for minimum period of 5 years after warranty period.

- (vi) Supply of complete technical, installation, administration and user documentation in English, in printed / soft-copy form / both.
- (b) The solution shall be deployed entirely on-premise within the BEML network. All processing of BEML data shall take place locally, and no BEML data shall be transmitted outside the BEML network in the course of normal operation.

#### **4.3 Pre-Qualification Criteria (PQC)**

Prospective Firm(s) should fulfil the mandatory conditions by submitting the response against the PQC Form (ANNEXURE – 3) with relevant supporting documents, certificates and undertaking letters, wherever applicable.

*NOTE: The condition of prior turnover and prior experience may be relaxed as per General Financial Rules (GFR) Rule 173 (i), for Micro & Small Enterprises (as defined by Department of Industrial Policy and Promotion) subject to meeting of other pre-qualification requirements of the EoI.*

#### **4.4 Technical Compliance:**

Prospective Firm(s) should be ready and willing to offer the Industrial Edge AI Device meeting or exceeding the basic technical specification outlined at ANNEXURE – 5, with relevant supporting documents, certificates.

#### **4.5 Submission and Process of EoI Evaluation:**

- (a) The Prospective Firm meeting PQC (as per ANNEXURE – 3) are invited to submit their response to this EoI.
- (b) Upon receipt of response(s) against this EoI, BEML will review the response(s) through a Technical Evaluation Committee (TEC) to ascertain conformance to the PQC and select eligible Prospective Firm(s) for further discussions.
- (c) The Eligible Prospective Firm(s) shall demonstrate all the features of Industrial Edge AI Device (mentioned in ANNEXURE – 5) via Proof of Concept (PoC) with physical device at BEML premises without cloud solution.
- (d) On evaluation, only shortlisted Prospective Firm(s) will be informed about their shortlisting.

#### **4.6 Post-EoI Onboarding Process:**

Prospective Firm(s) shortlisted on basis of this EoI (as per process defined under clause 4.5) shall be on-boarded through a limited tender for the procurement.

The mode, terms and conditions of said tender shall be communicated to only the shortlisted Prospective Firm(s) at that stage.

#### 4.7 Instructions:

4.6.1 The interested Prospective Firm(s) should submit their response(s) as per following ANNEXURES along with necessary supporting documents wherever required:

4.6.2 **Language:** All correspondences and documents related to the Eoi response shall be in English language, provided that any printed literature furnished by the Prospective Firm may be written in another language, as long as such literature is accompanied by a translation of its pertinent passages in English language in which case, for purposes of interpretation of the response to the Eoi, the English translation shall govern. However, if the translation is found to be incorrect subsequently, BEML will have right to take appropriate action against the Prospective Firm as may be deemed fit.

4.6.3 The person signing the response to the Eoi should have due written authorization from the Prospective Firm to sign the documents and should duly authenticate any errors or corrections in the Eoi. Over writing should be avoided. Copies of the credentials/ documents which are to be annexed must be self-attested and bear the signature and seal of the authorized signatory / authorised representative of the interested Entity/Firm/Company. The interested Entity/Firm/Company will be

requested to produce the originals of all information / documents as and when so required by BEML.

- 4.6.4 Multiple proposals by the same Prospective Firm shall not be accepted.
- 4.6.5 BEML at its discretion shall inspect the Prospective Firm's works/ office/ reference site premises etc., for the purpose of evaluation, as deemed necessary before selection of Prospective Firm. BEML's decision in this regard shall be final.
- 4.6.6 Any Prospective Firm which has been declared insolvent, bankrupted, debarred/blacklisted by Central/State Governments of India or by any entity controlled by Central/State Governments of India from participating in any of their project/tender, as on date of submission of Eol, shall not be eligible to submit the Eol.
- 4.6.7 BEML shall receive applications pursuant to this Eol in accordance with the terms set forth herein, as may be modified, altered, amended and clarified from time to time by BEML and all applications shall be submitted in accordance with such terms on or before the date specified in this Eol for submission of applications.

- 4.6.8 Restrictions on Prospective Firm from a Country which shares a Land Border with India:
- a. **4.8 REJECTION:** An Expression of Interest is liable to be rejected for any of the following conditions:

**4.7.1** The Expression of Interest is not accompanied by required documentation and has failed to provide clarifications related thereto, when sought by BEML.

**4.7.2** Misrepresentation, lack of proper documentation, fraud, coercion, undue influence, canvassing etc., by the prospective collaborator.

**4.7.3** The Expression of Interest is received after the closing time and date.

**4.7.4** Any information which would have entitled BEML to reject or disqualify the Prospective Firm becomes known to BEML after the Prospective Firm has been qualified.
