2. The employee was a member of EPS prior to 01.09.2014 and continued to be a member on or after 01.09.2014. Hence, this case shall be regulated as per Head Office circular No.Pension/2022/56259/16541 dated 20.02.2023 issued in pursuance to the Order dated 04.11.2022 of the Hon'ble Supreme Court of India in the matter of SLP(C) Nos.8658-8659 of 2019. The said circular lays down the following eligibility criteria for employees who, along with employer, may submit online Joint Option under Para 11(3) and 11(4) of the scheme:-

- (i) The employee and the employer(s) had contributed under paragraph 26(6) of EPF Scheme on salary exceeding the prevalent wage ceiling of Rs.5000/- or Rs.6500/-; and
- (ii) did not exercise joint option under the proviso to Para 11(3) of the pre-amendment scheme(since deleted) while being member of EPS, 1995; and
- (iii) were member prior to 01.09.2014 and continued to be a member on or after 01.09.2014.

3. The aforesaid circular dated 20.02.2023 also mentions about the following documents required to be submitted online alongwith the Joint Option:-

- (i) Proof of remittance of Employer's share in Provident Fund on higher wages exceeding the prevalent wage ceiling of Rs.5000/6500.
- (ii) Proof of joint option under Para 26(6) of the EPF Scheme duly verified by the employer(s).

4. The Joint Option has been examined in terms of the aforesaid circular dated 20.02.2023 and the following deficiencies have been noticed:-

- (i) The employee has NOT furnished proof of remittance of contribution in EPF above wage ceiling along with online application.
- (ii) The employer(s) has NOT furnished proof of remittance of Employer's Share in EPF above wage ceiling alongwith online application.
- (iii) It is NOT known whether the employee had exercised Joint Option under the proviso to Para 11(3) of pre-amended EPS, 1995 while being its member before 01.09.2014.
- (iv) The employee/employer(s) has NOT attached proof of Joint Option under Para 26(6) of EPF Scheme duly verified by employer and delivered to this office.

5. However, an opportunity is hereby given to submit within a period of one month the requisite information/documents as per deficiencies indicated at Para 4 above including the statement of NCP days. All the information/documents should be duly authenticated by Authorized Signatory of the Establishment. In case no response is received or complete details and documents are not received within the said period of one month, this case shall be decided on the basis of available details/records without further notice.
