Should the contractor fail to deliver the stores or any consignment there of within the period prescribed for such delivery, BEML will entitled at their option to recover from the contractor as agreed damages, and not by way of penalty will be recovered for delayed supplies @ 0.5% of the price of any stores not delivered per week or par there of subject to maximum of 5% of the value of the delayed portion of purchase order. GST at applicable rates shall be charged extra on the liquidated damages recovered.</p>
