- i) In the absence of Technical compliance report, the bids are liable for rejection.
- ii) Offers having validity less than 120 days are liable for rejection.
- iii) Bidders quoting for lesser credit days (i.e., less than 30 days for MSME and less than 60 days for others), the interest will be added while arriving the L1 status.
- iv) Bidders indicating advance payment should submit the Bank Guarantee (BG) for 110% of the order value in advance before execution of supplies & before release of payment. In the absence of confirmation on BG for 110% value, their offers will not be considered for evaluation.

In case, if the payment terms are not mentioned and bank guarantee is not accepted, it is presumed that the payment terms are advance payment without BG and hence, their offers will not be considered for evaluation.

In case, if the payment terms & BG confirmation are not mentioned, it is presumed that the payment terms are advance payment without BG and hence, their offers will not be considered for evaluation.

- v) IF Bidders not accepting for BEML terms & conditions, offers are liable for rejection. In case of non-submission of signed copies of BEML tender documents, their bids are liable for rejection.
