## **QUALIFICATION CRITERIA**

1. The tenderer shall be a stainless steel fabricator and shall have requisite in-house infrastructure facilities for manufacture and testing of stainless steel fabricated items. Company profile along with product range, infrastructure, manufacturing facility and test facility details shall be submitted along with the technical bid.
2. The firm shall have qualified welders for stainless steel fabrication. Valid Stainless steel welder qualification certificate and Welding Process Qualification (WPS & PQR) as per EN / ISO / DIN standard shall be submitted along with the technical bid.
3. The firm should have manufactured and supplied similar stainless steel fabricated items. Supporting documents for the supplies made shall be submitted along with the technical bid.
4. The firm should have established International Quality and systems certifications like ISO-9001 / ISO-14001 / IRIS. The certificates shall be submitted.
5. The firms shall submit the supporting documents for the above points. Technical offers of only qualified firms for the above criteria will be evaluated.

- 1. Two Bid System (Technical and commercial Offer separately).**
- 2. Vendor to upload Technical compliance report for attached Technical Delivery Conditions (TDC) in technical bid.**
- 3. Vendor to upload signed copy of Drawings with seal in technical bid.**

- 5. Vendor to upload Unit price /commercial offer in commercial bid separately.**
- 6. The commercial bids of technically qualified vendors will be considered for opened and further evaluation subject to BEML R&D clearance.**
- 7. L1 status will be arrived on individual item basis.**
- 8. Only manufacturer to be participated in the tender.**
- 9. Division of patronage: BEML reserves the right to place Purchase order on 100% Qty on L1 firm (or) In case of division of patronage the ratio 60(L1):40(L2) for two sources & for three sources L1 (50):L2 (30):L3 (20) at the final negotiate price of L1 as per purchase procedure.**
- 10. Commercial ranking will be arrived based on Landed cost of the tendered items including other charges, if any, pricing on statement of deviation. Landed cost would be arrived by considering the following components.**



**1. For Indian Vendors: (Landed cost calculation)**

- a) The firm to quote for unit price including packing and forwarding charges.
- b) Local freight and insurance charges would be added to unit price, if a firm does not agree for BEML standard delivery terms of FOR BEML BANGALORE COMPLEX.
- c) GST as applicable at the time of submitting the quotation.
- d) Loading interest for payment terms, if firm does not agree BEML standard payment terms of 60 days credit from the date of receipt and acceptance of material at BEML for Non MSME firms, the interest loading would be added @ 12% per annum for the deviant number of days.

**2. For Foreign Vendors : (Landed cost calculation)**

- a) Prices should be on F.O.B. (Free on Board) suppliers nearest port basis only. If firm does not agree for FOB terms then those quotation may liable for rejection. This conditions to be complied in GTC and uploaded along with Technical Bid.
  - b) Further on the FOB price, cost insurance freight (CIF) would be added to arrive at CIF prices @3% on FOB charges and Local freight would be added @1.5% on CIF.
  - c) Loading interest for payment terms if not agreed as per BEML standard payment terms of 100% by an irrevocable Letter of credit in favor of supplier payable within 60 days from the date of shipment @ 12% per annum would be added.
  - d) Customs duty if any for clearing the consignment at customs at the prevailing rate at the time of submission of quotation.
11. Non-recurring charges (NRC): Bidders may indicate lump sum price for non-recurring activities as defined/specified in BEML PTS underspecified line item in SRM portal. Detailed breakup to be provided in text. In case, bidder does not indicate any NRC charges, it is presumed by BEML that such costs are amortized by the bidder along with equipment costs.
12. For the purpose of arriving the Landed Cost in INR, the exchange rates for EUR / JPY prevailing as on date of tender opening (date of technical bid opening in case of two-bid tender) as per website [www.xe.com](http://www.xe.com) will be considered.
