#### 1. Pre-Qualification Bid:

(iv) In 'Type of Corporate / Institution, select "PSU-Public Sector undertaking" and Click on the "Go" button.

(v) In PSU-Public Sector undertaking- Name dropdown, select "BEML Limited Bangalore Complex" and Click "Submit" Button.

(vi) In 'Select Payment Category', dropdown option, select "EMD Tender Fee BEML Bangalore complex"

(vii) Please fill the details in the page displayed

(vi).EMD payment should be done before the Closing Date & Time of Tender as specified in the Tender Document. If EMD Payment is done after the Tender closing Date & Time, the offers are liable for rejection.

Technical Bid and Commercial bid are to be submitted through electronic mode only in the SRM portal.

b. Corrigendum regarding the tender if any will be published in BEML website only before the tender closing date. Bidders to make note of the above and check the

website before tender closing date / time to have the latest communication / update. The same to be signed with company seal and scanned copy to be uploaded with the technical bid documents.

c. Documents as indicated in the qualification criteria sheet are to be uploaded in Collaboration Folder on SRM Platform. (Commercial bids of the bidder will be opened only if all the technical requirements are fulfilled and qualified through technical evaluation. Hence the bidders are advised to upload all the required documents carefully.)

d. The tender documents will be considered at the sole discretion of M/s BEML Ltd, whose decision in the matter will be Final & Binding

### 3) Submission of Commercial Bid:

1. This being an annual term contract, percentage (%) above or below MES SSR 2010 rates shall remain firm for a period of ONE year.
2. The tenderers are requested to write the percentage (%) above or below MES SSR 2010 in FIGURES as well as in WORDS against each section of Bill of Quantities. In case of any discrepancy between the two those written in WORDS shall take precedence.
3. The tenders should confirm to MES specification and our conditions in every detail and any tenders not confirming to specifications and conditions are liable to be summarily rejected.
4. Firm should fill-up the detailed break-up in 'Bill of Quantities' and upload the filled Bill of Quantities in "Notes and Attachments".  
"Do not upload the filled - Bill of Quantities in 'C-Folder Technical Attachments' and ensure that it is uploaded in 'Notes and Attachments' only"
5. L1 will be considered by taking cumulative average percentage (%) of all line items of Factory Area and Township Area separately. Subsequently average of subtotal for Factory Area and Township Area will be taken for arriving L1 status. Purchase order will be placed on only ONE firm for both Factory Area and Township Area as KIT basis.

Percentage (%) above or below MES SSR 2010 quoted in Price bid conditions in SRM should be in line with percentage (%) above or below MES SSR 2010 quoted in Bill of Quantities. In case any difference between these two, in line items lower percentage will be taken for calculation purpose

6. In Bidders commercial bid, if any difference in percentage (%) above or below MES SSR 2010 quoted in Price bid conditions in SRM and Bill of Quantities, then the "LOWEST" will be considered for evaluation.

7. Pre-Qualification Bid will be opened first, subsequently; Technical Bids of the pre-qualified bidders will be opened on the specified date and time. Commercial Bids of the technically accepted bidders only will be opened subsequently on completion of the technical evaluation
8. Bidders whose 'Price bid - Bill of Quantities is not uploaded in the "Notes and Attachments" will not be considered for "final evaluation" even if the bidder is technically accepted.
