9) Performance Bank Guarantee (PBG): The successful tenderer shall furnish a Performance Bank Guarantee for 10% of contract value to be executed by any Indian Public Sector Banks only issued within 15 days after award of letter of Acceptance by BEML to ensure satisfactory operation of the contract. The Performance Bank Guarantee should be valid for a period of six months beyond the expiry date of the warranty. In the event of extension of contract, the PBG shall also be extended automatically by the firm.

9.1) Return of Performance Bank Guarantee (PBG): The Performance Bank Guarantee will be returned to the successful tenderer after six months of the expiry of warranty
