1) INTRODUCTION

This Expression of Interest (EoI) seeks response from applicants, who are interested to associate with BEML for participation in MMRDA Bid 'MONORS3' for Design, Manufacture, Supply, Testing and Commissioning Of 10 Nos. of Monorail Train Sets of 4 Cars Each And Training Of Personnel For Mumbai Monorail.

2) About BEML Limited:

- 2.1 BEML Limited (formerly Bharat Earth Movers Limited) was established in May 1964 as a Public Sector Undertaking for manufacture of Rail Coaches & Spare Parts and Mining Equipment at its Bangalore Complex. The Company has partially disinvested and presently Government of India owns 54 percent of total equity and rest 46 percent is held by Public, Financial Institutions, Foreign Institutional Investors, Banks and Employees. BEML Limited, plays a pivotal role and serves India's core sectors like Defence, Rail, Metro, Power, Mining and Infrastructure. The Company started with a modest turnover of Rs. 5 Cr during 1965 and thanks to its diverse business portfolio, the company has been able to achieve a turnover of more than Rs.3,000 Cr.
- 2.2 The Rail & Metro business of BEML Limited, was established to cater to the manufacturing needs of rolling stock in India. Starting 2002, BEML has successfully diversified into manufacturing of the state-of-the-art stainless steel Metro cars. BEML has been a pioneer in this area having supplied over 1600 metro cars till date. BEML's esteemed customers in metro segment include Delhi Metro, Bangalore Metro, Jaipur Metro and Kolkata Metro. Further, BEML secured the driverless metro car contract for the prestigious Mumbai Metro Line 2 & 7 project, which is presently under execution. Delhi Metro, the nation's most successful metro, is one of the major customers to BEML and more than 60% of the rolling stock run by Delhi Metro is supplied from BEML factory.
- 2.3 In the Railway segment, since its inception, BEML has successfully rolled out varied range of products such as Rail Coaches, AC EMUs, DC EMUs, Stainless Steel EMUs, Rail Buses, 4 & 8 Wheeler OHE cars, Track Laying Equipments, Spoil Disposal Units, Utility Vehicle, BWTB Wagons, BFAT Wagons, BRSTN Wagons and BOMN Wagons. BEML Limited is the first rail Coach-manufacturing unit in India to get ISO 9001 accreditation. The division is accredited with ISO9001-2015, ISO 14001-2015 & BS OHSAS 18001-2007 certifications. As of date over 18000 coaches have been supplied to Indian Railways. BEML truly epitomizes the "Make in India" initiative of the Government of India.

3) Scope of Cooperation

- 3.1 Through this EoI, BEML intends to select an applicant with whom, BEML can associate and attempt to submit MMRDA Bid No. 'MONORS3'. The mode of association is to be discussed and agreed between the Parties. The complete set of Bid No. 'MONORS3' tender document along with addendums / corrigenda can be downloaded from https://etendermmrda.maharashtra.gov.in/. Alternatively, the same can be obtained from BEML based on written request through email to rj@beml.co.in.
- 3.2 The selected applicant shall have to be the technology provider to BEML for Monorail rolling stock. Actual scope split to be discussed and agreed.
- 3.3 Duration of cooperation: Specific for MMRDA 'MONORS3'. During the course of association, both parties may mutually discuss and agree to extend the cooperation for further time as decided.

4) INFORMATION TO APPLICANTS

- **4.1** Reputed Rolling stock suppliers may submit the application on their letter head along with all the documents as prescribed in this EOI document.
- 4.2 Notwithstanding anything to the contrary mentioned in the document, by virtue of submission of the application against this BEML EOI, the applicant is deemed to have perused and fully understood the 'MONORS3' tender document along with addendums / corrigenda and is aware of the site conditions and the existing structure of Mumbai Monorail project.
- 4.3 Any applicant from a country which shares a land border with India will be eligible to participate in this EOI only if the applicant is registered with the Competent Authority as mentioned in the Office Memorandum of Ministry of Finance, DoE F No.6/18/2019-PPD dated 23rd July 2020 and comply with the extant Government rules and orders.
- 4.4 Expression of Interest documents of the applicant are to be signed by Authorized Person with Proof of Authority to be enclosed. The same shall be sent through email / post / courier or handed over in person to the following addresses within 07 days of the publication of this EOI i.e. 18.12.2020 @ IST 1500 Hrs:

- 4.5 The details submitted by the applicants shall be complete in all respects and BEML may seek clarifications / additional information as considered necessary. Such clarifications / additional information must be provided within 02 days of BEML request.
- 4.6 Any request for clarification on the Eol document may be submitted at the above address, within 04 days from the date of issue of Eol.
- 4.7 Reponses to EoI are to be submitted in English only. Supporting documents, as required, should also be in English language. In case of some documents are available in language other than English, the applicant shall necessarily provide duly authenticated translated version of the same in English.
- **4.8** All the pages of the EoI submission shall bear the sign and seal of the authorized signatory of the company.
- **4.9** BEML reserves the right to withdraw / cancel the EoI proceedings without assigning any reasons whatsoever.

4.10 **Evaluation Methodology:**

- A) The applicants qualified in initial filter criteria at ANNEXURE 3 shall only be considered for further evaluation as per ANNEXURE 4. There shall be no minimum qualifying points for ANNEXURE 4.
- B) For conversion of foreign currency into Indian Rupee, the exchange rate as on the date of submission due of EoI as per https://www.xe.com will be adopted.
- C) BEML shall identify and approach the applicants for association in the descending order of the total points obtained in the Evaluation at ANNEXURE 4. Detailed discussions on techno-commercial matters and other terms & conditions shall be held with the shortlisted applicant.
- D) The applicants shall note that this EoI is primarily for addressing the Monorail rolling stock tender; As such, any applicant who does not satisfy or comply with the requirements of Bid "MONORS3" is liable to be rejected.


